### Booths

Booths will be located in Longhorn Exhibit Hall F. **Cost for a 10 x 10 booth is \$650.00. Your reservation and booth fee must be received by July 30, 2010 to confirm your booth (s) space.** You will receive a confirmation upon receipt of your payment. The \$650.00 is only for the booth space and does not include lunch.

**The exhibit booth package includes:** A 10'x10' booth with an 8' high back drape, 3' high side divider drape, one (1) 7"x44" company name sign, one (1) 30" inches wide, x 30" high x 6' long draped table, two (2) side chairs and one (1) wastebasket. Pipe and drape will be provided for privacy.

A service kit will be sent via e-mail upon receipt of your booth confirmation form and payment. The service kit will contain: Convention Center Rules & Regulations, Utility Services request form, Credit Card Authorization form, Booth Layout document, Network & Telecommunication Services form, Exhibitor Audio Visual Order form, Exhibitor Signage and Rigging Order Form and Creative Greenery of Dallas form (for plants, etc.). Each service form will have an Advance Price Deadline date of August 1, 2010. If the exhibitors miss the opportunity for advance pricing, standard pricing (higher cost) will be applied after August 1, 2010.

Exhibitors will be allowed to set up booths on Monday, August 9, 2010 from 9:00am to 5:00pm. This will allow exhibitors more free time on August 10, 2010 to attend the educational portion of this event. **Please be advised that Booth the Exhibit Hall will close promptly at 5PM on the 9<sup>th</sup> so all booths must be completed at that time.**
